WRITTEN STATEMENT

On May 22nd, 2017 at approximately 10:00am, I, Officer Jeff Brooks, Animal Services Manager Robert Smith and Training Officer Casandra Scannell responded to the address of 6405 S. Virginia St (a business named "Puppies Plus") in response to numerous welfare complaints Washoe County Animal Services had received.

Upon arrival, I identified myself to the "Puppies Plus" front desk staff. The staff immediately allowed us access to view the store. Manager Smith inspected the Employee-Only area (see Statement R.Smith). I remained on the sale room floor with the store staff and Officer Scannell.

We began reviewing NRS required documentation at the front desk for each dog currently in the store. There was documentation from store staff that dogs A349515 and A349516 had shown signs of illness, but received no formal veterinary care and violated WCC 55.140 and WCC 55.455 6(f). Store Owner, Mike Schneider, arrived on scene approximately 30minutes after our arrival.


After reviewing the documentation, I determined that two dogs (A349515 and A349516) had lacked proof of veterinary care for over 30 days pursuant to NRS 574.450 2(b) and WCC 55.455 1(e). Both dogs were actively located on the sale room floor at the time of inspection and available for purchase, thus violating NRS 574.450 3.


When questioned, Schneider stated that he was in transition with his previous veterinarian. He admitted that he did not have a Primary Veterinary Care Program set in place at that time, thus violating NRS 574.440 and WCC55.455 6(h).

I discussed the violations I had found with Schneider. I advised of how to remedy to the problem to prevent future violations.

On May 26th, 2017 at approximate 10:00am, Officer Scannell and I met with Schneider at his business "Puppies Plus". We issued citations for the above stated violations.

WRITTEN STATEMENT

On May 5, 2017, I, Robert Smith, responded to Puppies Plus located at 6504 S Virginia to inspect the pet store in accordance with WCC 55.455. Upon arrival I met with store staff and viewed the following:

Three display enclosures contained two large breed puppies. The housing of dogs these size in an inadequate enclosure violates WCC 55.455 1(d).

Upon viewing the Employee-Only area, I saw four plastic storage containers. Each container had a dog inside of it with the lids secured shut with large rocks. According the staff present at the time, the containers were to ensure the dogs received a "breathing treatment". The housing of the dogs in these containers is a violation of WCC 55.4551(d) due to the size of the container and the animals' size.

When I asked Michael Schneider to present his Primary Veterinary Care Program for inspection, he stated he did not have one. This is in violation of WCC 55.455 6(f).

05/04/17 15:33 Cont-met with the staff at Puppies Plus to follow-up. The owner Michael Schneider was not there. I asked if the goldendoodle puppy had been examined yet and they called Michael and he said no it would be this afternoon or tomorrow. He was switching veterinary providers to Klaich AH.

I asked to see the puppy who was still in the back. This is a 3 month old F MC# 991001000935482. She appeared BAR I did not observe any discharge from her eyes or nose. They took her out of the cage and she was running around and did not have any mobility issue that I could see. I was having trouble taking a pic as she was very mobile. There was another Goldendoodle in a lower cage as well it was much larger and a darker red color. I asked the attendant why this dog was in the isolation area and she said it had a cough but was better. I explained that part of our complaint was for a darker Goldendoodle that was having trouble walking. She stated that the puppy we initially looked at was the one that a female patron had complained about. She was in the store and complained about the dog having trouble walking. 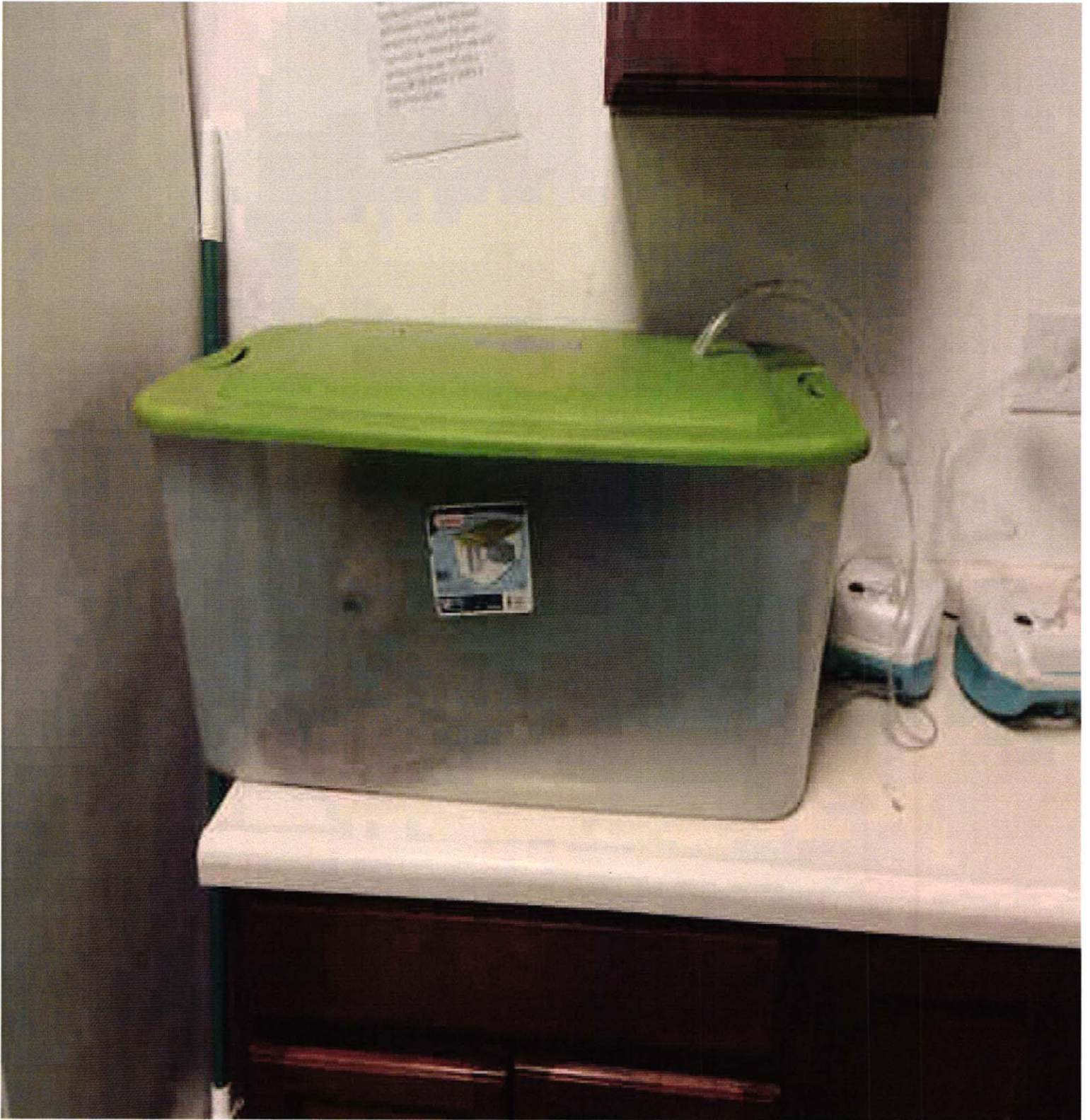

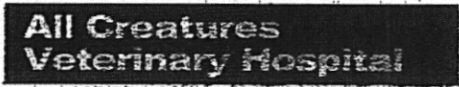

ON MAY 2, 2017, I WENT TO PUPPIES PLUS TO LOOK AT THE PUPPIES WITH MY NIECE. I OBSERVED A CARMEL/APRICOT GOLDENDOODLE (FEMALE). SHE APPEARED LETHARGIC AND WAS NOT ESPECIALLY INTERESTED. WHEN I WATCHED THE PUPPY STAND UP IN HER CAGE AND TURN AROUND SHE DID NOT APPEAR TO MOVE PROPERLY, AND HER SNOOT WAS CRUSTED OVER WITH GREEN/WHITE MUCUS THAT CLEARLY WAS THERE FOR SOME TIME SINCE IT WAS SIGNIFICANTLY CRUSTED. I ASKED TO LOOK AT THE PUPPY. WHEN SHE WAS PLACED IN THE VIEWING/PLAY PEN SHE WAS FRIENDLY. AT THAT TIME, I NOTICED SHE WAS NOT ABLE TO WALK PROPERLY SPECIFICALLY HER HIND LEGS SPLAYED OUT TO EACH SIDE. TO TEST THIS, I PLACED HER APPROX 5 FT FROM ME AND ENCOURAGED HER TO COME TO ME. SHE WAGGED HER TAIL, ATTEMPTED TO COME TO ME BUT EACH TIME SHE PLOPPED OVER ON HER RIGHT HIP AND WAS UNABLE TO WALK. I ALSO NOTICED JUST HOW PROFOUNDLY BAD SHE SMELLED AND THE CRUSTED MUCUS AROUND HER SNOOT. I MENTIONED TO THE ASSISTANT ON DUTY AND THE MANAGER THAT THAT PUPPY WAS NOT WALKING PROPERLY – THE ASSISTANT RESPONDED THAT IT WAS BECAUSE SHE WAS ON A TILED SURFACE. BOTH THE ASSISTANT ON DUTY AND THE MANAGER ATTEMPTED TO CONVINCE ME THAT THERE WAS NOTHING WRONG WITH THE PUPPY. HOWEVER, THIS WAS NOT AN ISSUE FOR ANY OF THE OTHER PUPPIES. I ALSO BROUGHT TO THEIR ATTENTION THAT THE PUPPY SEEMED UNWELL, AND I POINTED OUT THE NASAL DISCHARGE. THE STAFF SEEMED GLIB AND UNCONCERNED. I INSISTED THAT THEY LOOK AGAIN AT THE PUPPY AT THAT TIME THE STAFF CONCEDED SHE MIGHT HAVE A LITTLE COLD. I EXPLAINED THAT SHE SEEMS TO HAVE MORE THAN A COLD. THE MANGER REFUSED TO ACKNOWLEDGE THAT THE PUPPY WAS NOT CAPABLE OF HOLDING UP HER HIND END TO WALK. ALTHOUGH THE GIRL THAT BROUGHT OUT THE PUPPY SEEMED VISIBLY UPSET BY THE ENCOUNTER. THE MANAGER STATED THAT THEY WOULD TAKE HER IN THE BACK ROOM AND CLEAN HER UP AND BRING HER BACK TO US FOR A SECOND LOOK. HOWEVER, SHE LATER CAME BACK AND REFUSED TO BRING BACK THE PUPPY. I HAD OFFERED TO PURCHASE THE PUPPY, THE MANAGER SAID NO THEY COULD NOT SELL HER NOW THAT I HAD POINTED OUT THERE WAS SOMETHING WRONG WITH HER, I EXPLAINED THAT I SHOULD NOT HAVE TO POINT OUT THE OBVIOUS. I EXPLAINED THAT PUPPY NEEDS MEDICAL ATTENTION, THE MANAGER REPLIED THAT SHE WOULD PROBABLY SEE A VET ON THURSDAY. I STATED THAT THE PUPPY NEEDS A VET NOW AND I ASKED PERMISSION TO SEND MY VET TO THE STORE SHE REFUSED. THE MANAGER THEN TOLD ME THAT THE VET WAS IN SURGERY ALL DAY BUT THAT THEY WOULD HAVE THE VET COME TO THE STORE ON TUESDAY. I ASKED THE VET'S NAME SHE REFUSED TO FURNISH THAT INFORMATION. WHILE I WAS WAITING FOR THE CARMEL/APRICOT FEMALE TO COME BACK OUT TO THE PLAYPEN I WANDERED BY THE OTHER PUPPIES. I NOTICED ANOTHER FEMALE GOLDENDOODLE PUPPY ON THE LEFT WALL APPROXIMATELY MID-WAY DOWN THE WALL IN THE LOWER CAGES. LIKE THE OTHER PUPPY SHE APPEARED TO BE SLEEPING WHILE MOST OF THE OTHER PUPPIES WERE BARKING AROUND HER. I TAPPED ON THE GLASS TO SEE IF SHE WOULD RESPOND – SHE DID NOT. I ASKED TO SEE THAT PUPPY AND THE STAFF WALKED PAST AS IF THEY HAD NOT HEARD MY REQUEST, I REPEATED MY REQUEST BUT I WAS IGNORED. I THEN ASKED TO SEE THE LARGER MALE GOLDENDOODLE THAT WAS VERY PLAYFUL AND BOISTEROUS BUT THAT REQUEST WAS ALSO IGNORED. SEVERAL OF THE OTHER PUPPIES ON THE FAR LEFT WALL ALSO HAD DISCHARGE FROM THEIR EYES AND SNOOTS ALTHOUGH THEY APPEARED RELATIVELY ENERGETIC. THE CARMEL/APRICOT FEMALE PUP HAD REGURGITATED HER FOOD AND IT WAS ON THE CAGE FLOOR APPROX 24 INCHES AWAY FROM HER UNEATEN FOOD. THE REGURGIATED FOOD WAS OBVIOUS SINCE THE TEXTURE APPEARED DIFFERENT FROM THE OTHER FOOD AND HAD MUCUS THROUGH THE FOOD. I WAS SO CONCERNED BY THIS EXPERIENCE THAT I CALLED MY HUSBAND AND A FRIEND AND ASKED IF THEY WOULD GO DOWN TO THE STORE SEPARATELY. ON MAY 2ND 2017, I WENT TO PUPPIES PLUS WITH MY AUNT TO LOOK AT SOME PUPPIES WE WANDERED THE STORE AND MY AUNT CAME ACROSS THIS SWEET LITTLE FEMALE GOLDENDOODLE PUPPY THAT SEEMED RATHER UNWELL SHE HAD GREEN GUNK AROUND AND IN HER NOSE AND SHE SEEMED VERY QUIET AND UNINTERESTED WHICH I FOUND STRANGE AS PUPPIES ARE NORMALLY QUITE ENERGITIC BUT SHE APPEARED QUIET ILL. MY AUNT AND I WERE VERY CONCERNED AND WE ASKED THE LADIES TO BRING HER OUT SO WE COULD TAKE A BETTER LOOK AT HER.
